健康保険料の保険料率は、88.0/1000 (被保険者 44.0%+事業主 44.0%) 88.0‰=基本保険料(54.994‰)+特定保険料(31.706‰)+調整保険料(1.30‰)
 介護保険料の保険料率は、20.0/1000 (被保険者 10.0%+事業主 10.0%) 40歳以上65歳未満の方は、健康保険料に介護保険料が加わります。
 賞与時の保険料は、千円未満を切り捨てた支給額に上記と同じ料率を掛けた額です。健康保険・介護保険の年度累計上限額は、573万円となります。
 厚生年金保険に於ける賞与の保険料計算は、健康保険料の時と同じ計算方式によりますが、1回の支給につき(同月に2回以上支給されたときは合算)150万円を上限とします。
